That the applicant herein, Amoco Production Company, is hereby authorized to complete its Mayajo Tribal "N" Well No. 2 located in Unit G of Section 20, Township 26 forth, Range 18 West, MMPM, San Juan County, New Mexico, in such a manner as to permit the injection of salt water for disposal purposes into the Pennsylvania; "D" formation at approximately 6237 feet to approximately 6252 feet through 2-7/8 inch toring with a packer set at approximately 6150 feet.

IT IS FURTHER OND RED:

The jurisdiction of this cause is hereby retained by the Commission' for such further order or orders as may seem necessary or convenient for the prevention of waste and/or protection of correlative rights; upon failure of applicant to comply with any requirement of this order after notice and hearing, the Commission was terminate the authority hereby granted in the interest of conservation. That applicant shall submit monthly reports of the disposal operation in accordance with Rules 704 and 1120 of the Commission Rules and Regulations.
