DETAILS OF WORK

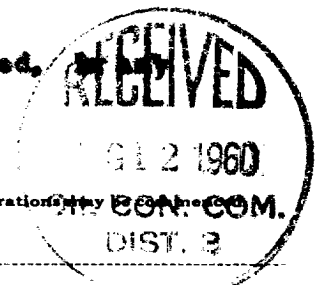

4. A dual Dakota-Pictured Cliffs completion will be considered. If event, PC will be protected by cement.

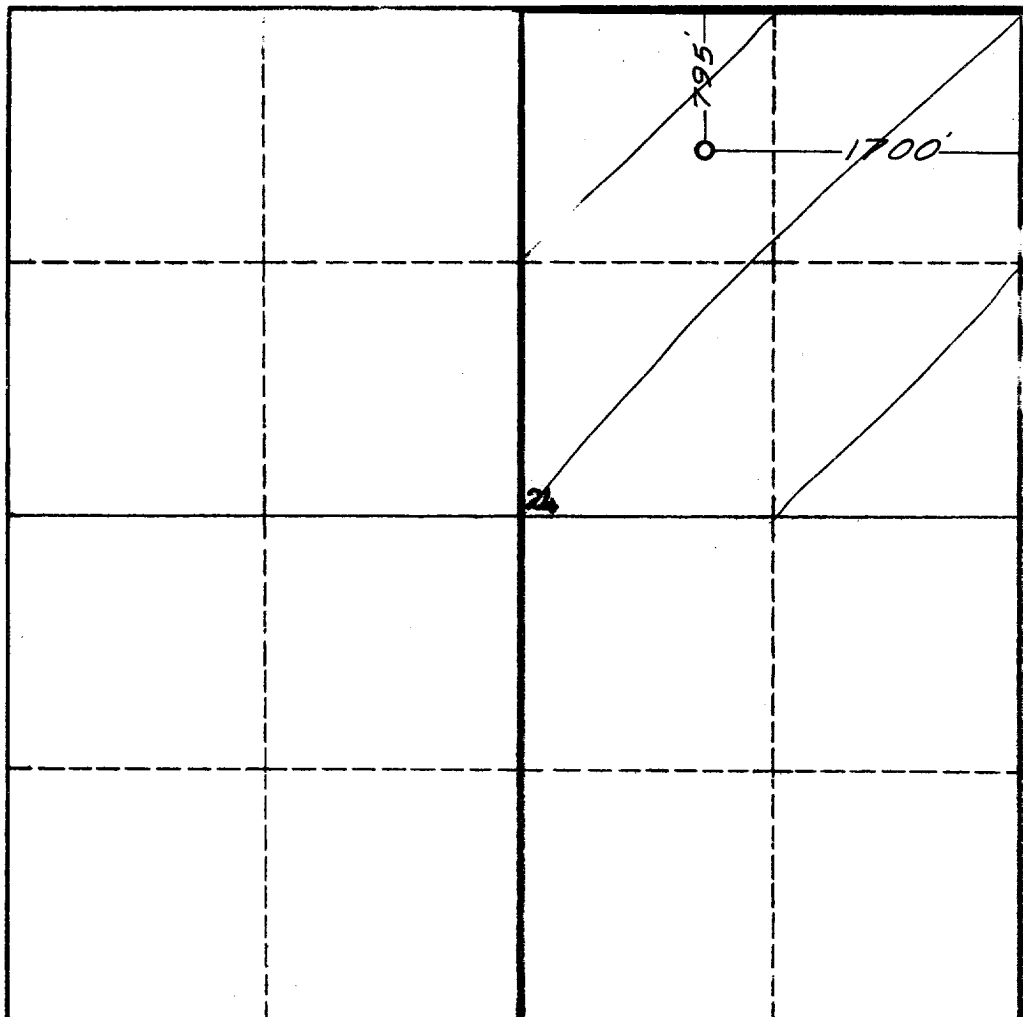
