The designated drilling unit is the N/2-NE/4 of Section 19-26N-13W, San Juan County, New Mexico.

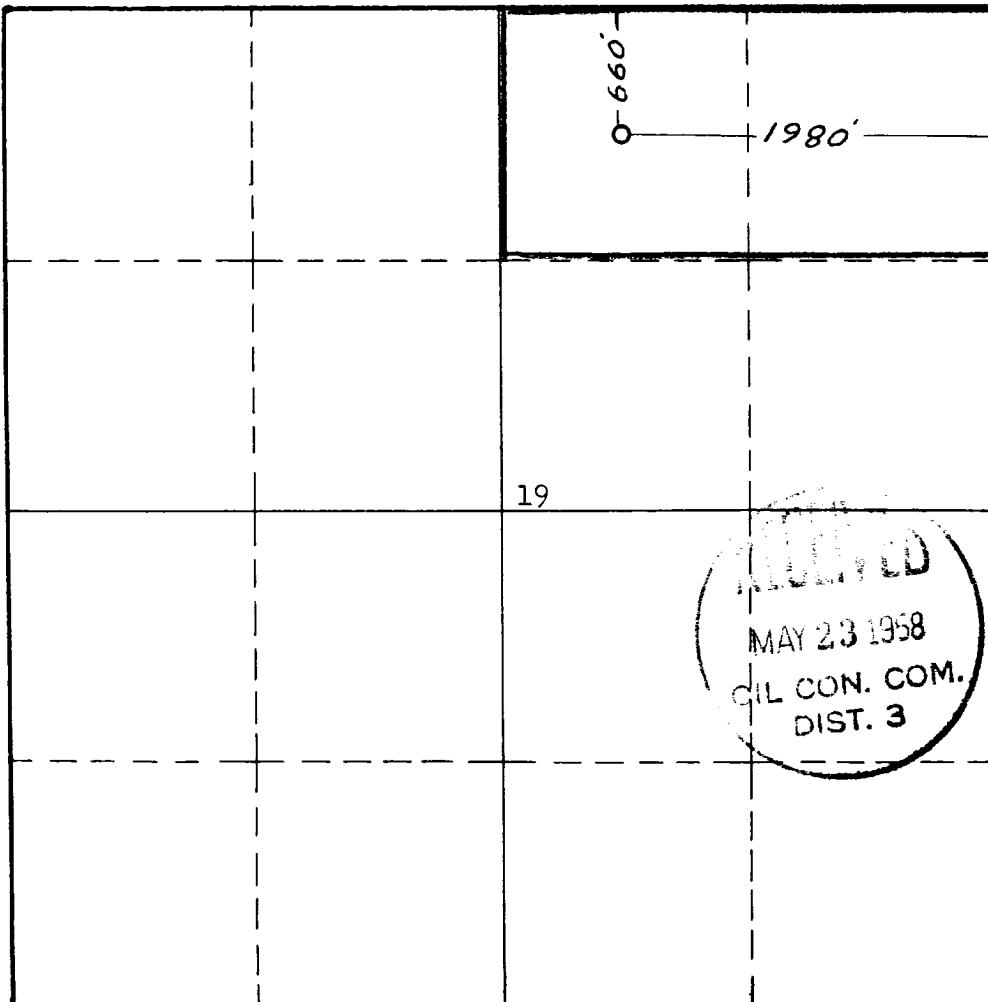
