Determine possibility of repairing casing or plugging as follows:

1. Run packer to isolate holes in casing. If casing can be repaired, proceed with return to injection. If un-repairable, plug.
2. Spot 100' Class B cement plug across Gallup top at 4900'.
3. Perforate 50' below Mesa Verde top at 2445' and spot 100' Class B cement plug inside and outside production casing.
4. Perforate 50' below Pictured Cliffs top at 1687'. Spot Class B + 4% gel cement plug to cover Fruitland top at 1380' inside and outside production.
5. Spot Class B + 4% gel cement inside casing at 310'. Cement to surface with Class B + 4% gel cement. (Outside previously cemented through hole at 282'.

CONDITIONS OF APPROVAL

1. Plugging operations authorized are subject to the attached "General Requirements for Permanent Abandonment of Wells on Federal and Indian Leases."
2. **Mike Flaniken** with the Farmington Office is to be notified at least 24 hours before the plugging operations commence (505) 599-8907.
3. The following modifications to your plugging program are to be made (when applicable):

1.) Spot Gallup cement plug from PBTD to 5183'
plus 50 linear feet excess. (Gallup top @ 5183')

2.) Perforate @ 568', place a cement plug from 568'
to 400' inside & outside the casing plus 100' excess.
(Bottom of C-30 Alamo @ 518')
