We received a copy of Notice of Intention to Drill and Form C-128 in connection with your #13 A.L. Buff well in Unit N, Section 18-26N-13W. We note that Section 18 is an irregular section and that your dedicated unit contains 95.49 acres. As this well is in the Bisti Lower Gallup Pool the standard unit would consist of 80 acres. Before the production of oil from this unit can be approved it will be necessary that you secure administrative approval for the communitization of the fractional lot as set out in Rule 104, Paragraph N.

This application should be directed to Mr. A. L. Porter, Director of the Commission. If immediate approval is desired waivers from offset operators should be secured. In any event offsets should be notified of your application and the Commission will wait 10 days before approving pooling if no objection is made.
