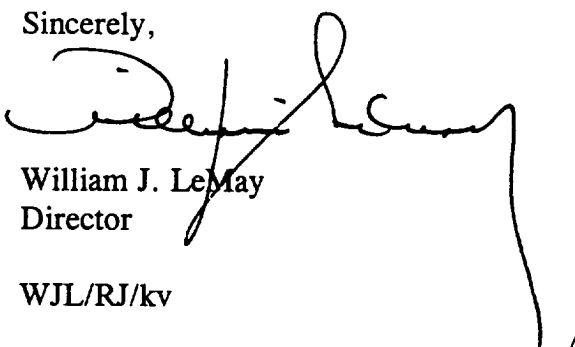

Conditions:

The operator shall place adequate cement prior to running 3 ½" casing, or alternatively at the time of plugging and abandonment to insure that the Ojo Alamo Formation is completely sealed off with cement. The methodology to be employed shall be approved by the Division's Aztec office prior to commencement of any remedial work.

The Division reserves the right to rescind this authority in the event that waste appears to be resulting therefrom.
