DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Spudded hole 11-14-53.

Set 185' of 10 1/2" 36 # casing on bottom of 13 1/2" hole and cemented with 125 sacks of regular cement. Cement circulated to the bottom of the cellar. On 11-15-53.

On 11-17-53 we tested casing with 600 # pressure for 30 minutes. It held pressure O.K. We drilled out cement & shoe and retested with 600# for 30 minutes and it still held pressure O.K. Tested from 12 to 1:30 A.M.
