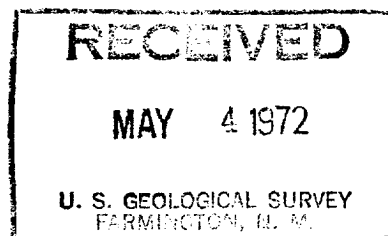
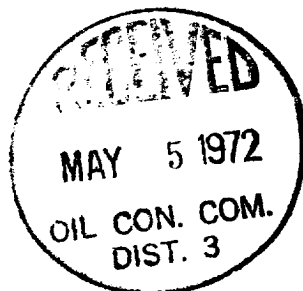

## Instructions
