400' of 10-3/4" @ 32.75# casing, cemented with 350 lbs. reg. cement, circulated.

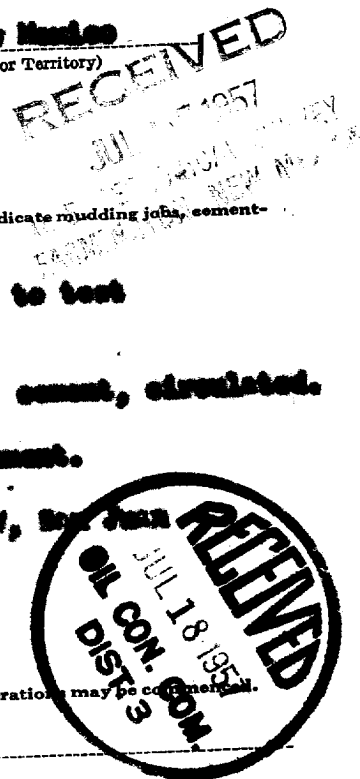
5300' of 5-1/2" @ 14# casing, cemented with 250 lbs. reg. cement.

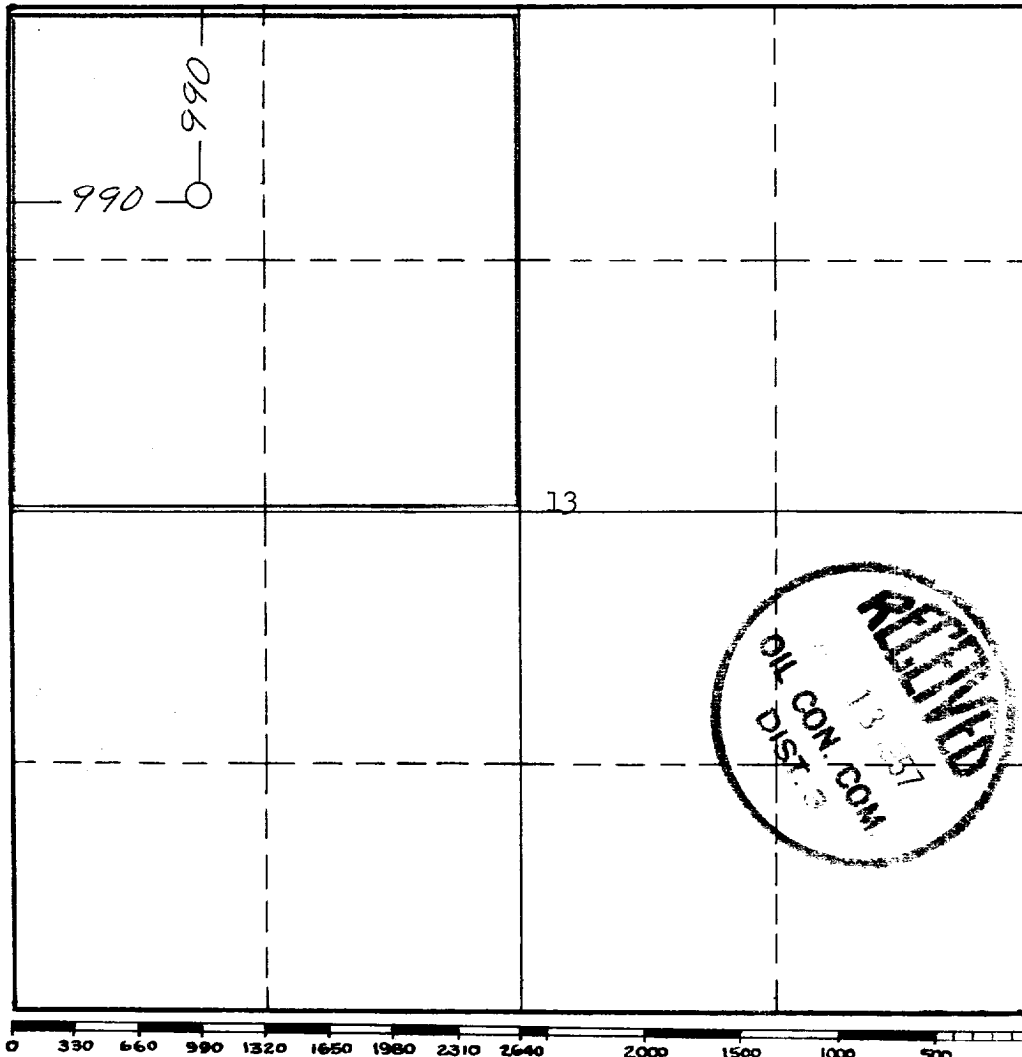
