Dear Mr. Reed:

Reference is made to your letter of October 30, 1958 regarding packer leakage test on your State "J" well #1 located in Unit D, Section 16-26N-11W. Our rules require that an initial packer leakage test be conducted on all dual completions. Immediately after completion the two sides are required to be shut in a minimum of seven days. Then in the case of gas wells a 3-hour potential test is conducted, the shut-in pressures being recorded on the shut-in side. As your well is an oil-gas dual I would suggest that you pursue the following procedure in securing a packer leakage test:

Shut both sides in for seven days, record the 7-day shut-in pressure, flow the oil well completion for three hours and record the Dakota shut-in pressures at 15-minute intervals for the first hour and at 30-minute intervals thereafter. Submit this information to us in duplicate in letter form. Further packer leakage tests may then be conducted after you have a gas-well connection.

The Commission is at present in the process of printing a new packer leakage test form which will include instructions on all San Juan Basin dual completions. As soon as we have received a supply of these we will forward some to you.
