Rig up, pull tubing, ran retrievable bridge plug on 2 3/8" tubing set @ 5812' pressure test bridge plug and tubing to 2400 lbs. pick packer up, found bottom hole in casing @ 4235' and top hole @ 2945' set packer @ 2660' squeeze 450 sacks cement + 6% Gel + 2% cal cl. out holes in casing. W. O. C. 38 hrs. drill solid cement from 2790' to 4235' pressure test every 90 ft. to 1500 lbs. displace hole with treated water, fish out bridge plug lay down 2 3/8" tubing ran 1 1/2" tubing in hole, ran 191 jts. + 30' subs total of 6331 (non-upset) with 3 jts. 1 1/2" I.J. below packer set 10,000 lbs. on Model "D" packer 7,000 lbs. on donut, flange up well head swab well, released rig 2:30 P.M. 2-20-78.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
