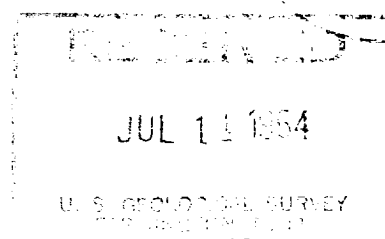
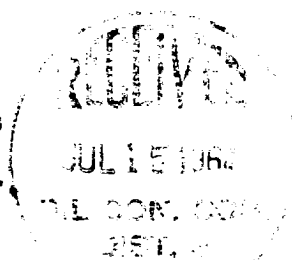

On 6-24-64, this well was plugged & abandoned in the following manner:

1. Spotted 35 sack cement plug thru tubing, (2163-2190').
2. Tubing stuck, backed off @ 1300', laid down tubing.
3. Shot 5 1/2" casing; off @ 1054'. Spotted 20 sack cement plug across cut off & pulled 5 1/2" casing.
4. Spotted 10 sack cement plug in surface with 4' x 4' dry hole marker.

Instructions
