

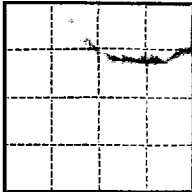

DETAILS OF WORK

It is our intention to drill Well No. 1 to approximately 5200' to test the Gallup formation. Our casing program is as follows:

400' of 10-3/4" OD 32.7% casing, cemented with 350 sks. reg. cement, circulated.
5200' of 5-1/2" OD 14# casing, cemented with 250 sks. reg. cement.

The designated drilling unit is the SE 1/4 of Section 12-24N-12W, San Juan County, New Mexico.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

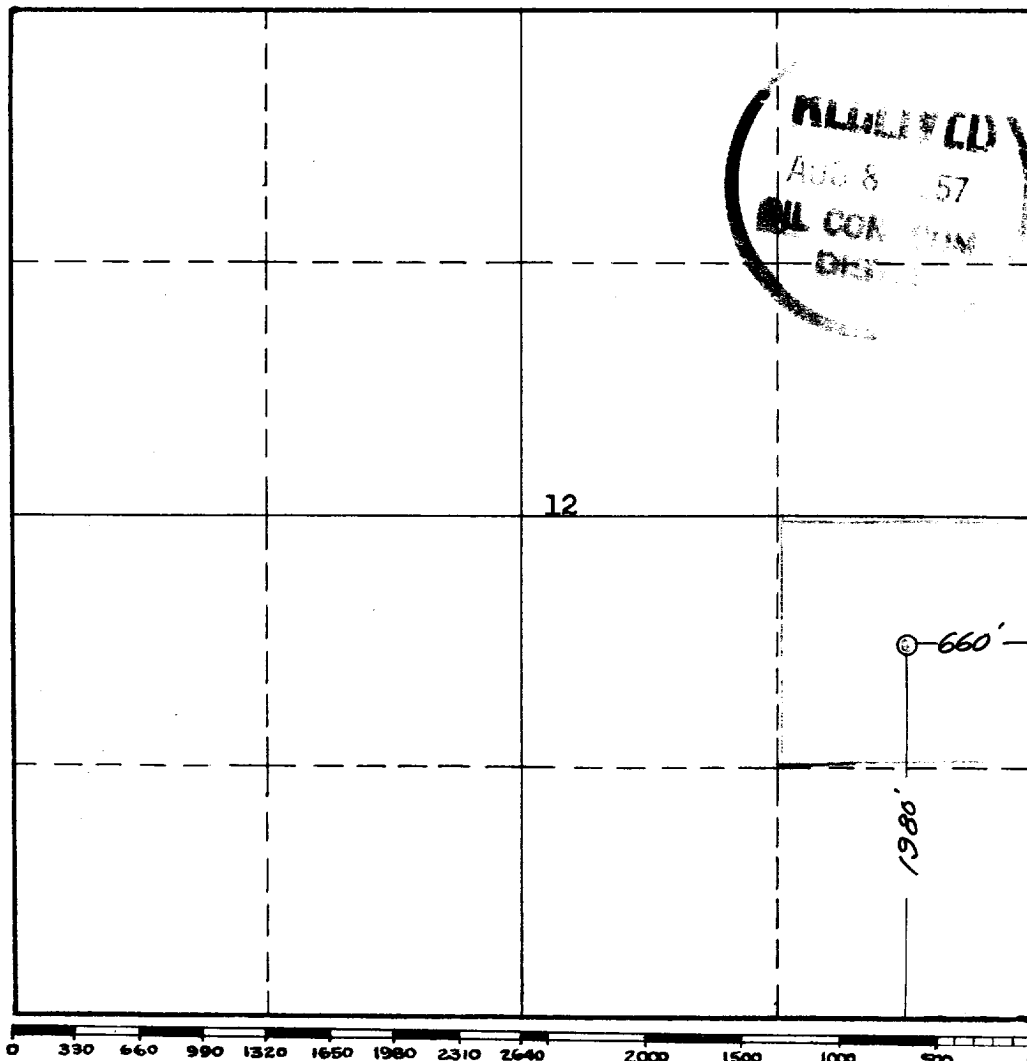
