DETAILS OF WORK

It is our intention to drill Well No. 2 to approximately 5300' to test the Gallup formation. Our casing program is as follows:

400' of 10-3/4" OD 32.7% casing, cemented with 400 sacks reg. cement, to be circulated.

5300' of 5-1/2" OD 14% casing, cemented with 250 sacks cement.

The designated drilling unit is the SW 1/4 - SE 1/4 of Section 11-26N-13W, San Juan County, New Mexico.

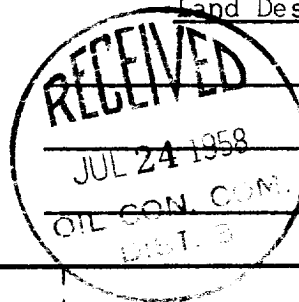

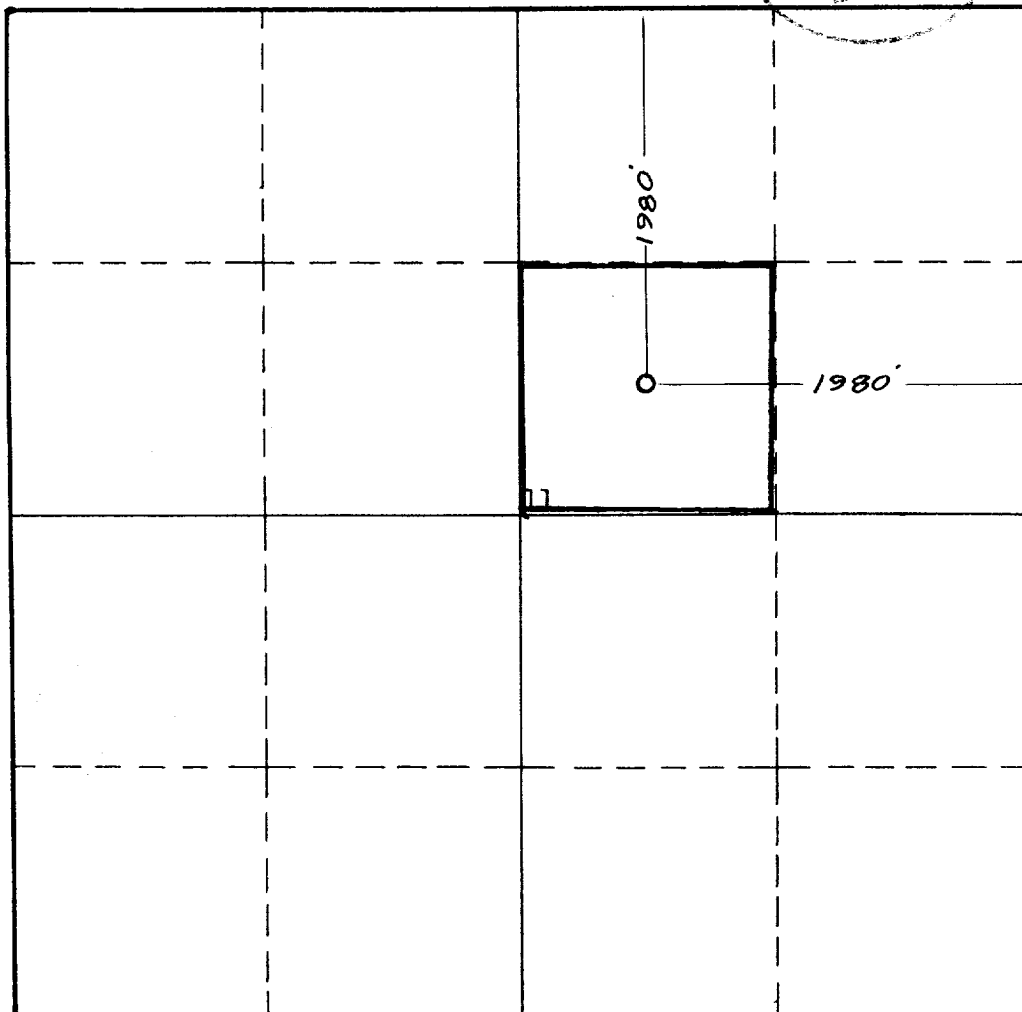

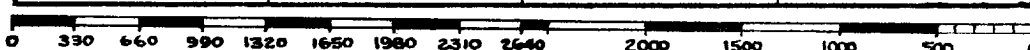
