400' of 10-3/4" OD 32.75# casing, cemented with 350 sacks of cement, cement to be circulated.

5300' of 5 1/2" OD 14# casing, cemented with 250 sacks of cement.

The designated drilling unit is the SW 1/4 - NW 1/4 of Section 11-26N-12W, San Juan County, New Mexico

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

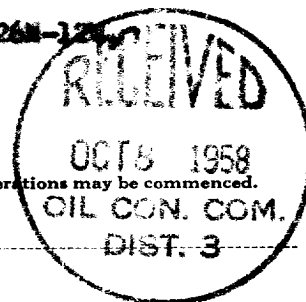

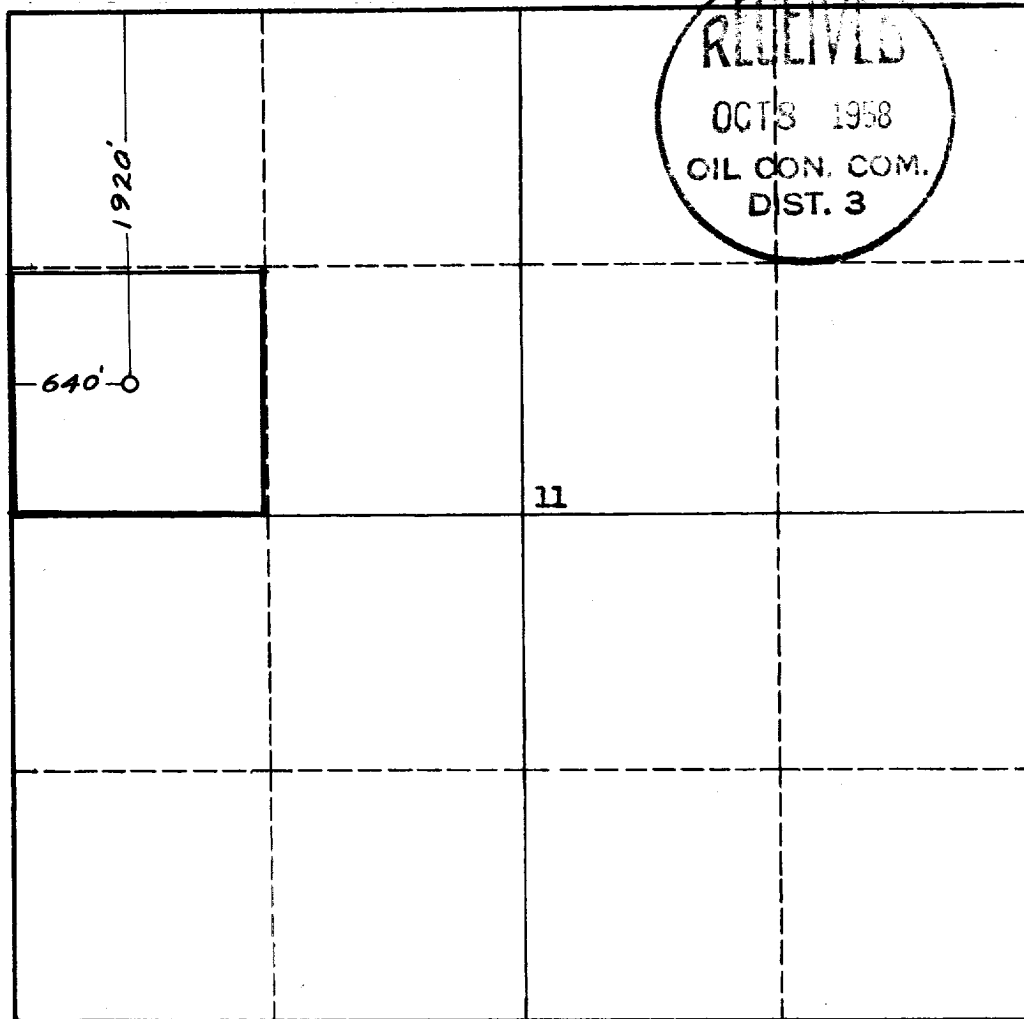
