DETAILS OF WORK

Propose to drill with rotary tools to the top of the Pictured Cliff Formation - Expected between 1,900 feet and 2,100 feet below surface - then drill 4-3/4" hole through Pictured Cliff formation. Completion with cable tools - and shooting with solidified nitro glycerin or sand oil fracturing.

Casing program: 100 feet of 8-5/8" new 8 rd. thd. 32# casing. Circulate cement to surface.

5-1/2" O.D. 114# J-55 seamless casing to be set on top of Pictured Cliffs formation, cemented with 150 sacks regular cement.

1" tubing to be set within 50 feet of total depth for production.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

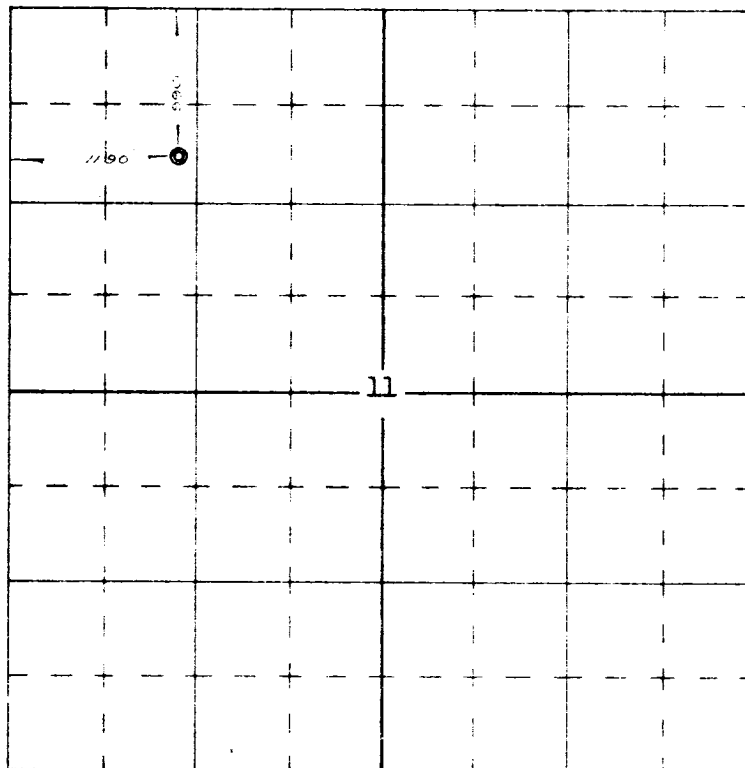
