5900' of 5-1/2" OD 14# casing, cemented with 200 sks. reg. cement.

The designated drilling unit is the NE 1/4 - NW 1/4 of Section 12-26N-12W, San Juan County, New Mexico.

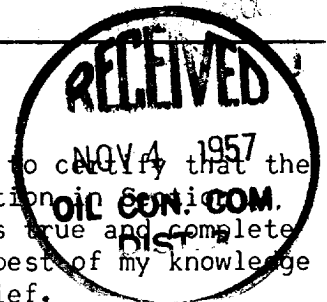
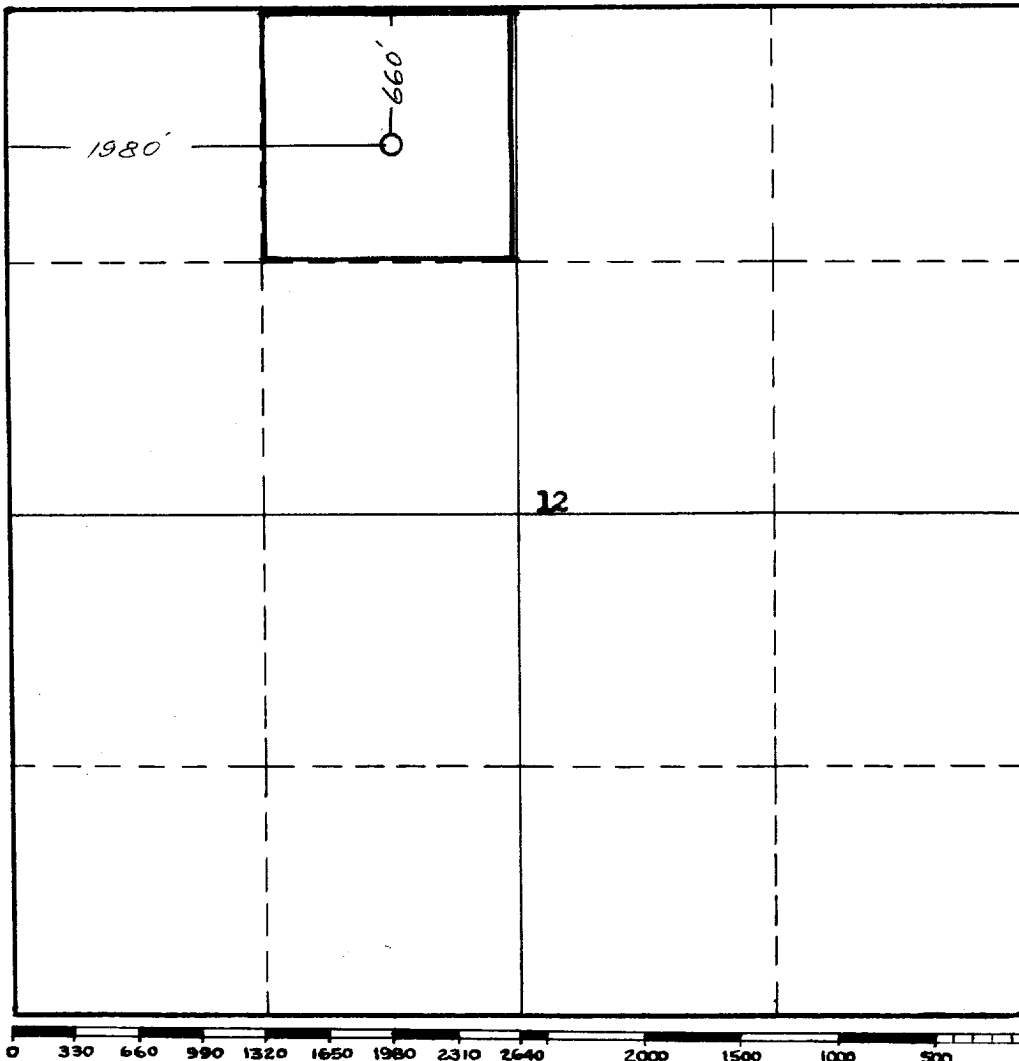
