February 24, 1968, moved in and rigged up pulling unit. Squeezed perforations 5078-5100' with 15 sacks of cement, 3X gal. Top of plug at 4950'. Worked 5-1/2" OD casing at 140,000#. Found free point at 2030'. Shot 5-1/2" OD casing at 2030'. Circulated with 120 barrels of water to kill well. Spotted 30 sack cement plug 1956'-2088'. Pulled 5-1/2" OD casing as follows: 15 joints (508') 15.34 J-55 RT&C "C" condition; 46 joints (1537') 14# J-55 RT&C R2 condition "C" casing. Total casing pulled 61 joints (2047'). Spotted 30 sack cement plug 400-500'.

Placed 10 sack cement plug in top of surface casing with dry hole marker. Plug and abandon 2/28/68.

## Instructions

**General:** This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

**Item 4:** If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

**Item 17:** Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
