The designated drilling unit is the SW/4 SW/4 of section 1-26N-12W, San Juan County, New Mexico.

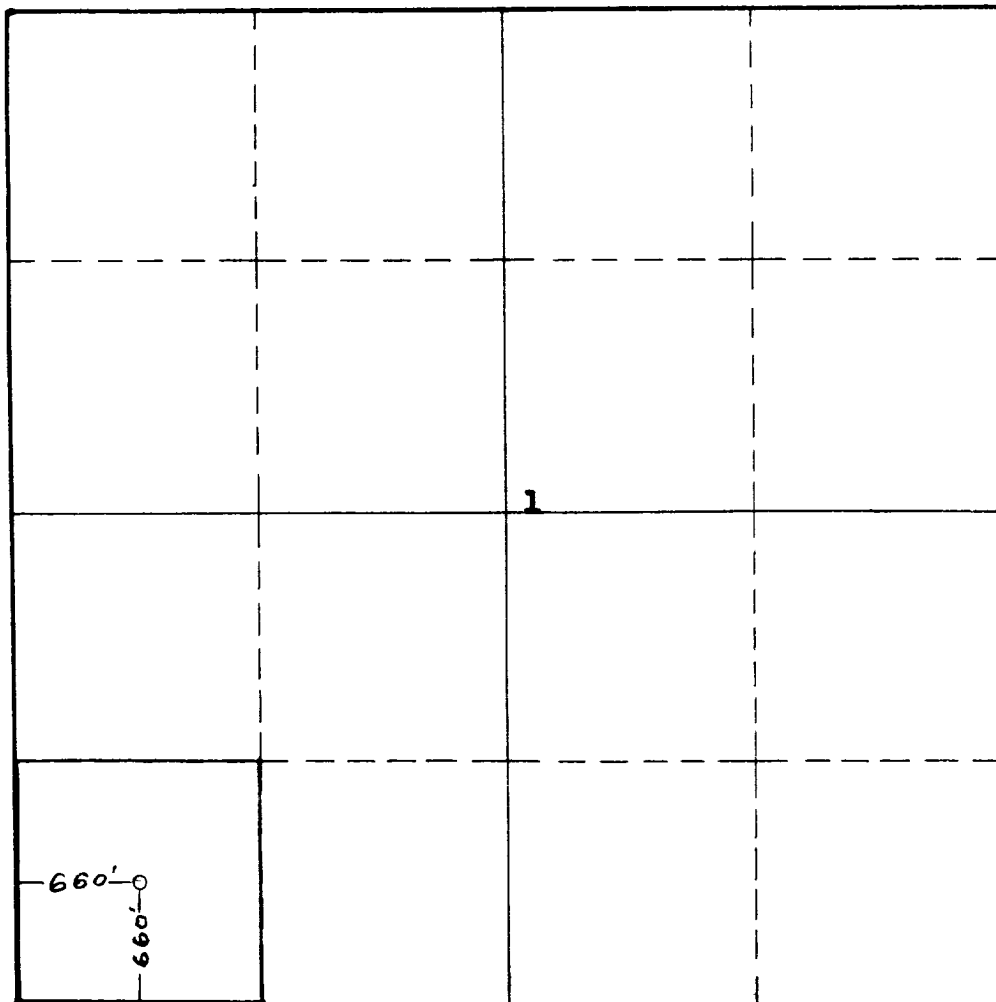
