2-14-68 moved in and rigged up pulling unit. Squeezed Gallup perforations 5146-5162' with 20 sacks of cement, 31 gal. Top of cement plug at 4960'. Worked 5-1/2" casing with 140,000#; found free point at 2300'. Shot 5-1/2" casing at 2300', 2284'. Unable to pull free. Shot 5-1/2" OD casing at 2175'; casing pulled free. Spotted 20 sacks of cement from 2125-2225'. Pulled 66 joints (2176') 5-1/2" OD, 14#, J-35, condition "C" casing. Spotted 20 sacks cement from 450-550'. 10 sacks of cement in top of surface casing with dry hole marker. Last rig released 2/19/68.

Instructions
