**Worked 5-1/2" casing with 160,000# tension. Found free point at 1306'. Shot 5-1/2" casing at 1289'; casing pulled free. Spotted 20 sacks of cement from 1239'-1339'. Pulled 39 joints (1289') 5-1/2" OD 14# 8R R2 condition "G" casing.**

**Set 10 sacks of cement in top of surface casing with dry hole marker. Completed P&A 3/20/68.**

**Item 4:** If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
