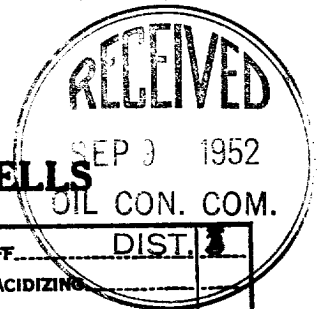

The elevation of the derrick floor above sea level is 6524 ft.

DETAILS OF WORK

The well was cased at 6:00 A.M., August 24, 1952. On August 24, 1952, 9-5/8" casing was landed at 104 feet with 100 sacks of cement. Cement plug down at 1:30 P.M., August 24, 1952. At 1:00 P.M., August 25, 1952, casing and water shut-off were tested at 450 pounds for 30 minutes, with no drop in pressure. Thirty-five feet of solid cement were drilled in bottom of pipe and water shut-off was again tested at 450 pounds for 30 minutes. There was no drop in pressure during this test and drilling operations were resumed.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
