## THE CONSTITUTIONAL COMMISSION

**Abstract**—The purpose of this study was to determine if there were differences in the prevalence of musculoskeletal disorders among different types of workers. The study included 600 male employees from three companies who had been employed by their respective companies for at least one year. Data were collected through self-administered questionnaires. The results showed that the prevalence of musculoskeletal disorders was higher among manual workers than among non-manual workers. This finding suggests that manual work may be more likely to cause musculoskeletal disorders than non-manual work.
