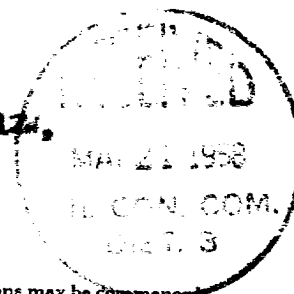

It is our intention to drill Well No. 5 to approximately 5300' to test the Gallup formation. Our casing program is as follows:

400' of 10-3/4" OD 32.75# casing, cemented with 350 lbs. cement, to be circulated.

5300' of 5-1/2" OD 14# casing, cemented with 250 lbs. cement.

The designated drilling unit is the NE 1/4 - SW 1/4 of Section 2-26N-12E, San Juan County, New Mexico.

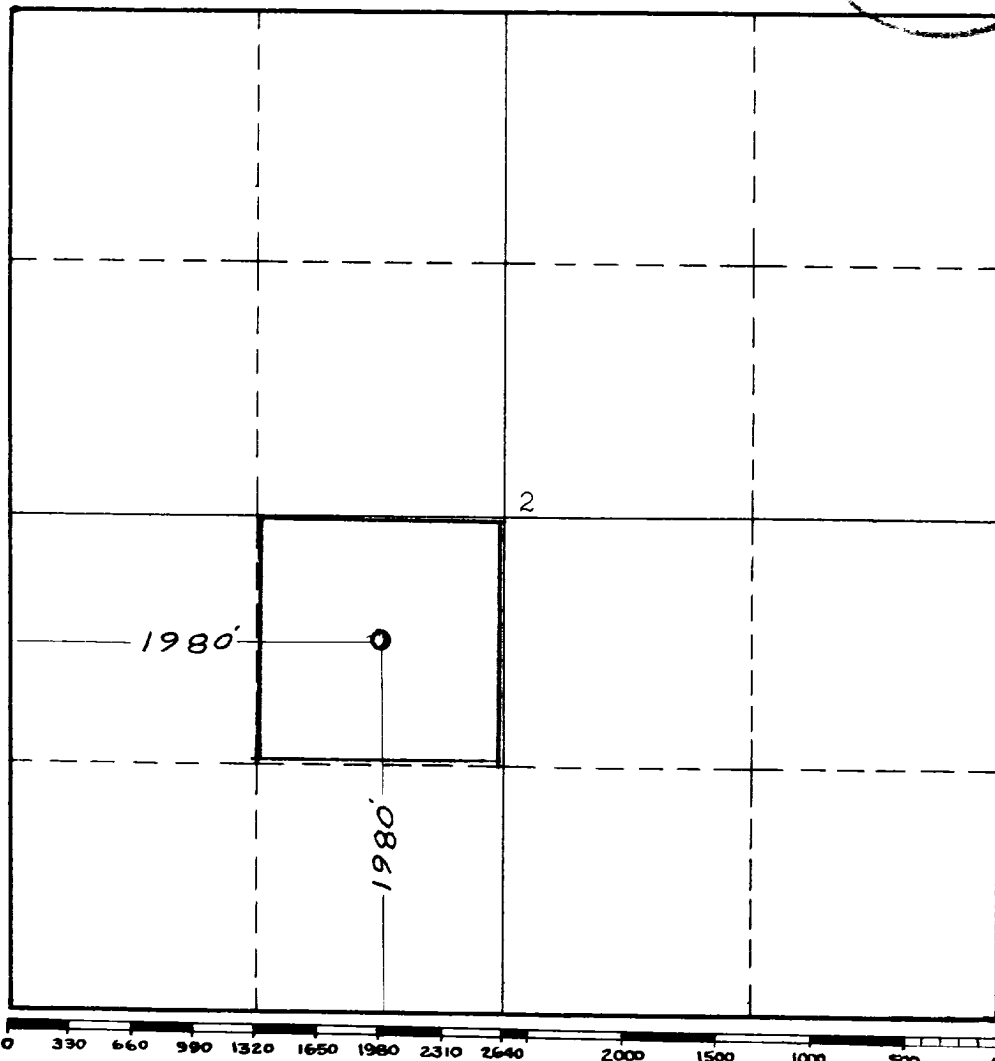
