January 26, 1968, moved in and rigged up casing pulling unit. Squeezed casing perforations 5057'-5070' with 15 sacks of cement with 3X gel. Estimated top of plug at 4920'. Worked 5-1/2" OD casing with 150,000# of weight. Found free point at 1250'. Shot 5-1/2" casing at 1234'. Spotted 20 sacks cement plug from 1184-1284'. Pulled 40 joints (1246') of 5-1/2" OD, 14#, J-55, R-2, condition "C" casing. Placed 10 sack cement plug in top of surface casing with dry hole marker.

Plugged and abandoned 1/30/68.

Instructions
