5/22/98 Catch fish. Jar stuck seal assembly.

5/26/98 Jar seal assembly loose. TOH. TIH with packer milling assembly.

5/27/98 Mill out Baker Model "D" packer at 6050'. TOH and lay down workstring.

5/28/98 Ran 198 joints 1 1/2" 2.9# tubing set at 6428'. SN @6395'.
