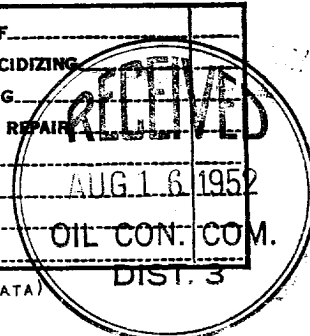

DETAILS OF WORK

We propose to drill the above well to approximately 2200 feet. Rotary tools will be used to total depth. Casing will be set on top of pay. Pictured Cliffs formation will be drilled with gas and cleaned out with gas after shot with SEC.

The following casing program is proposed:

Size	Depth	Amount	Remarks
9-5/8"	100	75	175% of calculated amount to circulate
7"	2100	150	100% of calculated amount to fill 1000' above shoe.
