Due to non-commercial production it is planned to plug and abandon this well in the following manner:

Set a cast iron cement retainer near the bottom of the 5 1/2" casing, approximately 2090', squeeze the open hole w/75 sacks Class C cement w/2% gel.

It is not intended to recover any of the 5 1/2" casing.

Put a 10 sack cement plug and 4" x 4' plug and abandonment marker in the top of the surface casing.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
