1/15/68 moved in and rigged up pulling unit. Pulled rods and 2-3/8" EUE J-55 tubing. Ran 2-3/8" tubing open ended. Squeezed perforations 5078-5109' with 15 sacks of cement, 15 gal. Top of plug at 4959'. Pulled tubing and rigged up casing jacks. Worked 5-1/2" casing. Shot casing at 2075'. Spotted 20 sacks cement plug 2025-2125'. Pulled 64 joints 5-1/2" OD, 15.5#, 5-2, J-55, condition "C" casing. Spotted 20 sack cement plug from 200' to 209'. 10 sacks cement in top of surface casing with dry hole marker.

Plugged and abandoned 1/21/68.

Instructions
