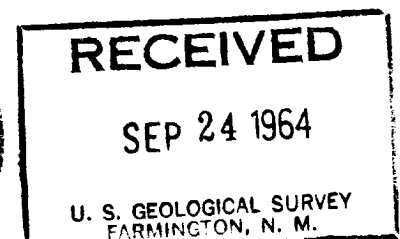
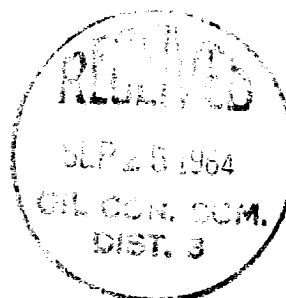

I.R. 28.3 BFM, Max. pr. 4000#, BDF 1000#, tr. pr. 2900-3692-4000#. Dropped 4 sets of 12 balls each. ISIP 1400#, 5 Min. SIF 1000#.

Instructions
