1/2/64 moved in and rigged up casing milling unit. Spaced perforations 1700'-2000' with 15 sacks of cement, 3/4 gal. Estimated top of plug 2357'. Palled 2-3/8" OD tubing. Worked casing with 150,000. Final free point at 2125'. Shot 5-1/2" OD casing at 2125'. Added 15 joints (2115') 5-1/2" OD, 15.5%, 8-55, 14, 1-2, "0" condition casing. Plugged as follows:

2150' - 2350' - 20 sacks cement
2375' - 2750' - 20 sacks cement

Placed 10 sack cement plug in top of surface casing with dry hole marker. Plug and marker 1/2/64.

Instructions
