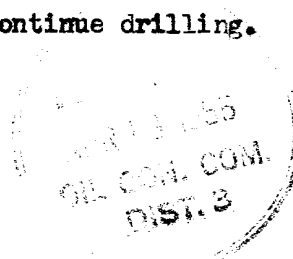

## DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Spudded well at 2:00 P.M. on April 8th.

On April 9th, reached total depth of 100.5' K.B. or 92.5' ground measurement. Cemented 91' of 8-5/8" OD 24# J-55 casing at total depth with 50 sacks neat cement and 50 sacks "Posmiz S". Circulated to surface.

Moved cable tool off. Awaiting rotary rig to continue drilling.
