This well has been abandoned and converted to a water well in the following manner:

On 5-23-58 set cast iron cement retainer at 3190', squeezed perfs (5372-5486') w/100 sacks of cement.

7-20-62 Set bridge plug at 1000', top of cement on 7 5/8" intermediate casing is at 2000'. Perf. 260-690' w/two 3 3/4" 90 gram torpedo jets, per foot. Water Supply was used to develop the Rincon Unit. Water well is known as the 28-7 Unit Water Well #1.

Instructions
