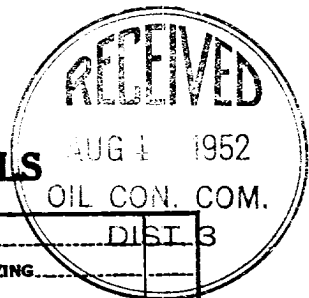

DETAILS OF WORK

1. Cut window from 4830' to 4850'.
2. Set A-1 whipstock at 4850'.
3. Drill directional hole to 5710'.
4. Shoot with two quarts per foot - entire Mesaverde.
5. Pull whipstock.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
