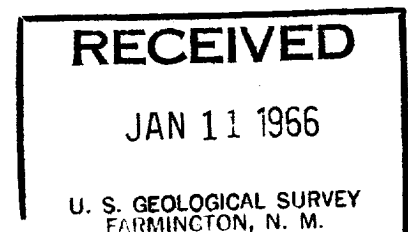
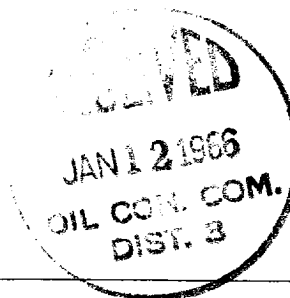

On 1-7-66 tested casing w/4000# O. K. Spotted 500 gallons 7 1/2% Acetic acid, perforated 6654-62', 6672-80', 6692-6700' w/2 SIF, started frac, locked up w/4620 gallons water in, standing pr. 1400#, flowed back 3 minutes, locked up w/5738 gallons in, standing pressure 2800#, flowed back 3 minutes, locked up 6920 gallons in. Had I.R. of 43 BPM before locking up.

1-9-66 Cleaned out to 6710', spotted 500 gallons 7 1/2% Acetic acid, resumed frac. Fraced w/30,000# 20/40 sand and 48,090 gallons water, 3% calcium chloride, 7# J-100/1000 gallons. BDP 2200#, tr. pr. 3300-3800-4200#. Dropped 2 sets of 16 balls each. Flushed w/4452 gallons. I.R. 28 BPM. ISIP 1800#, 15 minute 1500#.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
