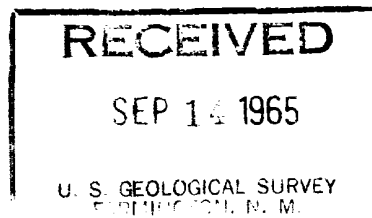
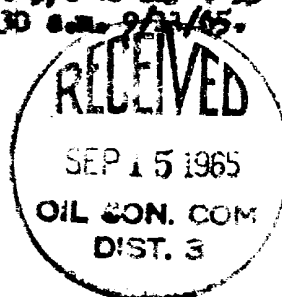

Instructions
