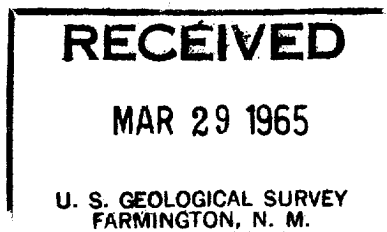

3/22/63 - DST #1 - Tested from 4864' to 4964', Upper Horness Zone, 4 Hr. Test, 4-1/2" DP, No Water Casing, 1/4" Stem & 1" Top Opening In Tool. Opened Tool, had a strong blow of air immediately and non-flammable gas. Gas vol. increased to 100 MCF Daily Rate in 30 Min. and decreased to 105 MCF Daily Rate in 1st Hr. and stayed @ 105 MCF for remainder of test. Closed tool for 90 Min. MWP. Pulled packers loose and recovered 280' (1.40 Bbls.) of gas cut dril. mud, no show of oil or water. TWP 20020, 177 1120, FWP 1000, 10 Min. 20020, 20 Min. 20020, 30 Min. 23000, 40 Min. 23730, 50 Min. 24130, 60 Min. 24420, 70 Min. 24820, 80 Min. 24960 and 90 Min. 25000.

Instructions
