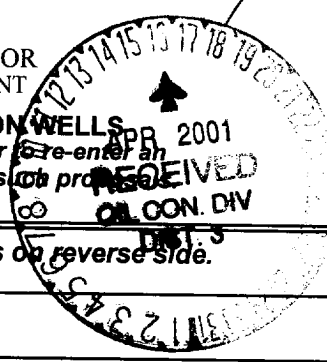

TOH w/ 2-3/8" tubing and setting tool. Loaded hole with water. Pressure test 4-1/2" casing to 1000# psi, test, ok. SI Bradenhead pressure was 265# psi. Primary seal was leaking in bottom of tubinghead. Cahnged out tunbinghead. Bled pressure off. TIH and retrieved RBP. TIH w/ production string. SWION12/15/00 Landed tubing, attempmt to hook up wellhead to flowline, unsucessful due to different tubinghead. Notified Donald Blair and Andy Ortiz that well is currently shut in, no production. RDMO
