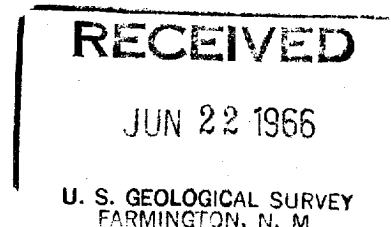
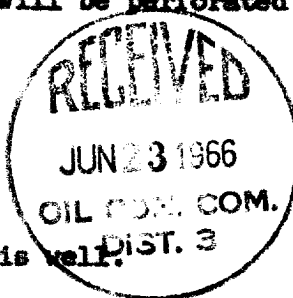

The production casing will be cemented; in three stages with sufficient cement to cover Dakota formation, Mesa Verde formation, and Pictured Cliffs and Kirtland formations. Selective zones in the Dakota formation will be perforated and sand water fractured.

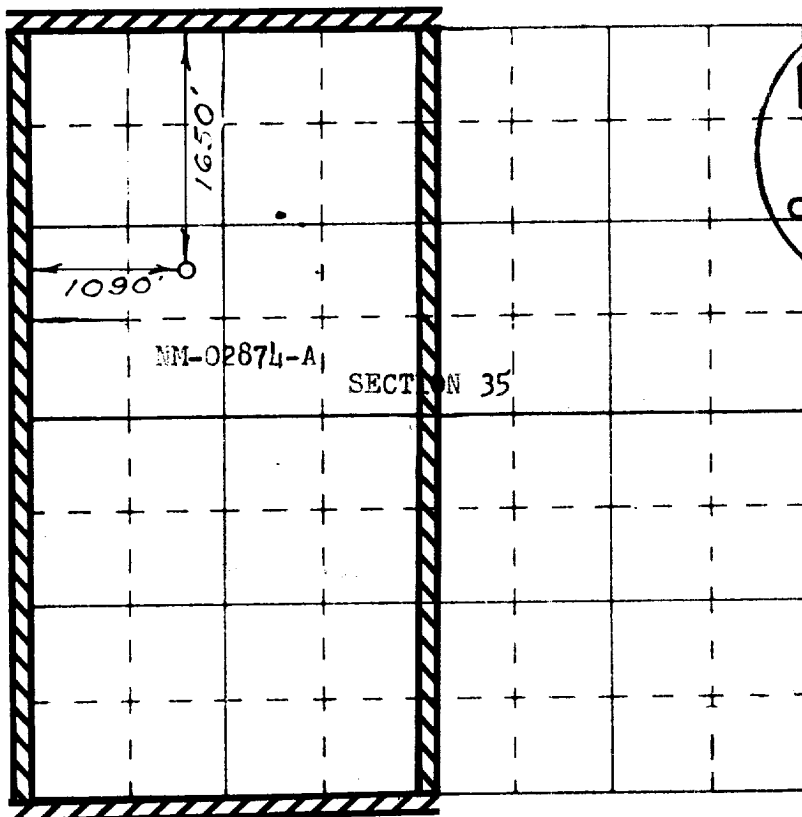
