On 1-25-67 ran 6 joints 8 5/8", 24#, J-55 casing (198') set at 213' w/160 sacks cement circulated to surface. W.O.C. 12 hours. Tested w/600#/30 minutes O. K.

On 2-8-67 Total depth 6964'. Ran 216 joints 4 1/2", 10.5#, J-55 casing (6951') set at 6964'. Second stage pool set at 4633', third stage tool set at 2303'. Cemented first stage w/270 sacks cement, second stage w/175 sacks cement, third stage w/165 sacks cement. W/O completion rig.

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
