In an attempt to increase production, the Navajo Tribal P^o No. 3 was acidized on December 14, 1968 with 3,000 gallons of 25% HCl. The well flowed 30 barrels of oil and 3 barrels of water in 24 hours after workover.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
