On 2-23-67 spudded well, drilled surface hole and ran 6 joints 8 5/8", 24#, J-55 casing (199') set at 213' w/210 sacks cement circulated to surface. W.O.C. 12 hours. Tested w/600#/30 Min. O. K.

On 3-6-67 T. D. 6895'. Ran 212 joints 4 1/2", 10.5#, J-55 casing (6884') set at 6895'. Second stage tool at 4964', Third stage w/ tool at 2395'. Cemented first stage w/270 sacks cement, second stage w/175 sacks, 3rd stage w/175 sacks. W.O.C. until completion rig moves on location.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
