On 3-10-67 T. D. 6673', ran 206 joints 4 1/2", 10.5#, J-55 casing (6661') set at 6673'. Second stage tool set at 4296', third stage tool set at 2330', cemented first stage w/240 sacks cement, second stage w/175 sacks, third stage w/180 sacks. W.O.C. until completion ~~minimum~~ rig moves on location.

Instructions

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
