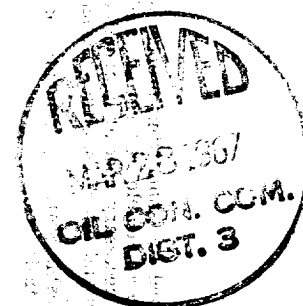

On 3-7-67 spudded well, drilled surface hole and ran 6 joints 8 5/8", 244, J-35 casing (169') set at 201' w/170 sacks cement. W.O.C. 12 hours, tested w/800/30 Min. C. K. Cement circulated.

On 3-19-67 T. D. 6695', ran 204 joints 4 1/2", 10.54, J-55 casing (6604') set at 6695'. Float collar at 6683', second stage tool at 4869', third stage tool at 2229'. Cemented first stage w/250 sacks, second stage w/170 sacks, third stage w/150 sacks. W.O.C. until completion rig moves on location.
