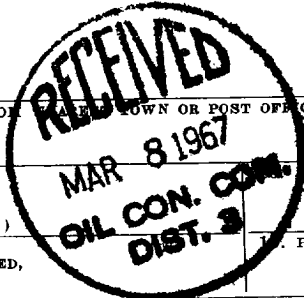

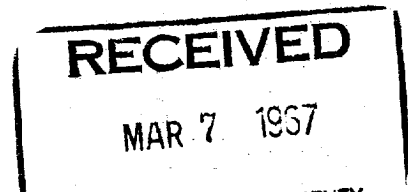
First Stage to fill from total depth to top of the Gallup formation.

Instructions
