On 3-21-67 spudded well, drilled surface hole and ran 6 joints 5 5/8", 204, J-55 casing (200') set at 213' w/170 sacks cement circulated to surface. W.O.C. 12 hours. Tested w/600#/30 Min. O. K.

On 3-31-67 Total depth 6650', ran 204 joints 4 1/2", 10.5#, J-55 casing (6640') set at 6650', float collar at 6640', second stage tool at 4704', third stage tool at 2233'. Cemented first stage w/260 sacks cement, second stage w/145 sacks cement, third stage w/165 sacks cement. W.O.C. until completion rig moves on location.

On 4-2-67 F.B.T.D. 6638', tested casing to 4000# O. K. Spotted 250 gallons 7 1/2% HCL, perf. Dakota 6492-98, 6550-62, 6572-84' w/12 SPZ, frac w/40,000# 40/60 sand, 40,010 gal. water. Max. pr. 4000#, MDP 2000#, tr. pr. 3500-3717-4000#. I.R. 37.3 BPM. Dropped 2 sets of 12 balls each, flushed w/4400 gal. water. ISIP 1500#, 15 Min. SIP 900#.
