On 4-13-67 spudded well, drilled surface hole and ran 6 joints 8 5/8", 24", J-55 casing (220') set at 212' w/170 sacks cement circulated to surface. W.O.C. 12 hours. Tested w/600#/30 Minutes O. K.

On 4-26-67 T. D. 6790'. Ran 210 joints 4 1/2", 10.5", J-55 casing (6779') set at 6790'. Float collar at 6780'. Second stage tool at 4947', third stage tool at 2264'. Cemented first stage w/310 sacks cement, second stage w/320 sacks cement, third stage w/190 sacks cement. W.O.C. until completion rig moves on location.

5-20-67 P.B.T.D. 6780', tested casing to 4000' O. K. Spotted 300 gallons 7 1/2% HCL, perf. Dakota 6580-98, 6612-20, 6671-95' w/24 SP2, free w/40,000' 40/60 sand, 40,000 gal. water. Max. pr. 4400#, BHP 3700#, tr. pr. 3400-3500-4400#. I.R. 44 BPM. Dropped 2 sets of 24 balls and 1 set of 18 balls, flushed w/4704 gallons water. ISIP 1700#, 5 Min. SIP 1100#, 15 Min. 800#.
