We sent a notice to correct the API # on the above well to you on 4-15-97, which you approved on 4-25-97. Apparently you made the effective date of the API number change effective with 4-97.

In order for Conoco to transmit production reports to the MMS we need to have the effective date to be 11-95. The API number was corrected by the NMOCD during the ONGARD system design and their search to determine the correct API numbers for every well. If you have deleted the former number you may need to establish this number all the way back to first production from this well. The former operator of this well was Merit Energy Co., Conoco Inc assumed operations effective with November 1, 1995.

Your help in correcting this problem will be appreciated. Once the API number effective date has been corrected we will transmit production numbers to the MMS.
