Total depth - 6385'

Perforate 5½" casing from 6226' to 6233' with 20 jet shots, 3 shots per foot. Set packer at 6170' with tubing tail pipe at 6230'. Swabbed well, no fluid recovered, had trace of gas. Acidized perforations with 500 gals. mud acid. Ran swab four (4) times and well commenced flowing. On initial flow well produced 127 barrels oil, 15 barrels water, and 12 barrels acid water thru an average choke of 20/64" in 8 hours for an average oil production of 15.9 barrels per hour.
