Commenced workover 5-9-71. Perforated additional pay from 2206' to 2208' and 2214' to 2220' with 4 jet shots per foot. Using pkr. and B.P., acidized new perms with 250 gallons 28% HCl acid and flushed with 500 gallons water. Inj. rate 2 BPM, max. pressure 500 psi, min 175 psi. Returned well to production 5-11-71. On 24 hour test ending 5-20-71, pumped 113 BO and 467 BW with GOR 1760.

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
